Limited Entry: Limited entries of 8 dogs per test. Closing date: 11:59pm March 25, 2024. Day of test entries will be accepted if limit of 8 dogs has not been reached.

Testing will be held both outdoors at a working barn with horses on the premises. Dogs are to remain on leash at all times. Please do not visit the test site prior to the test. No bitches in season.

Online entries must be signed and must include page 2 of this premium (Official American Kennel Club Herding Entry Form).

Day of test entries accepted if limit of 8 dogs has not been reached.
